Keynote:

Digital Transformation as a driver for competition

Digitalization and dematerialization are drivers for competing markets of tomorrow. The impact of ICT on business models and business life is enormous and transforms enterprises and markets fundamentally: Each single enterprise is challenged every day again by speed and new options of digital technologies and must defend the position in the networked society of next generation



enterprises. Digital technologies have evolved from "enabler" to core advantage of new business models and business performance: Critical to maintain success for the next strategic period in transformed networked digital society is the right and future ready design of security in all dimensions.
